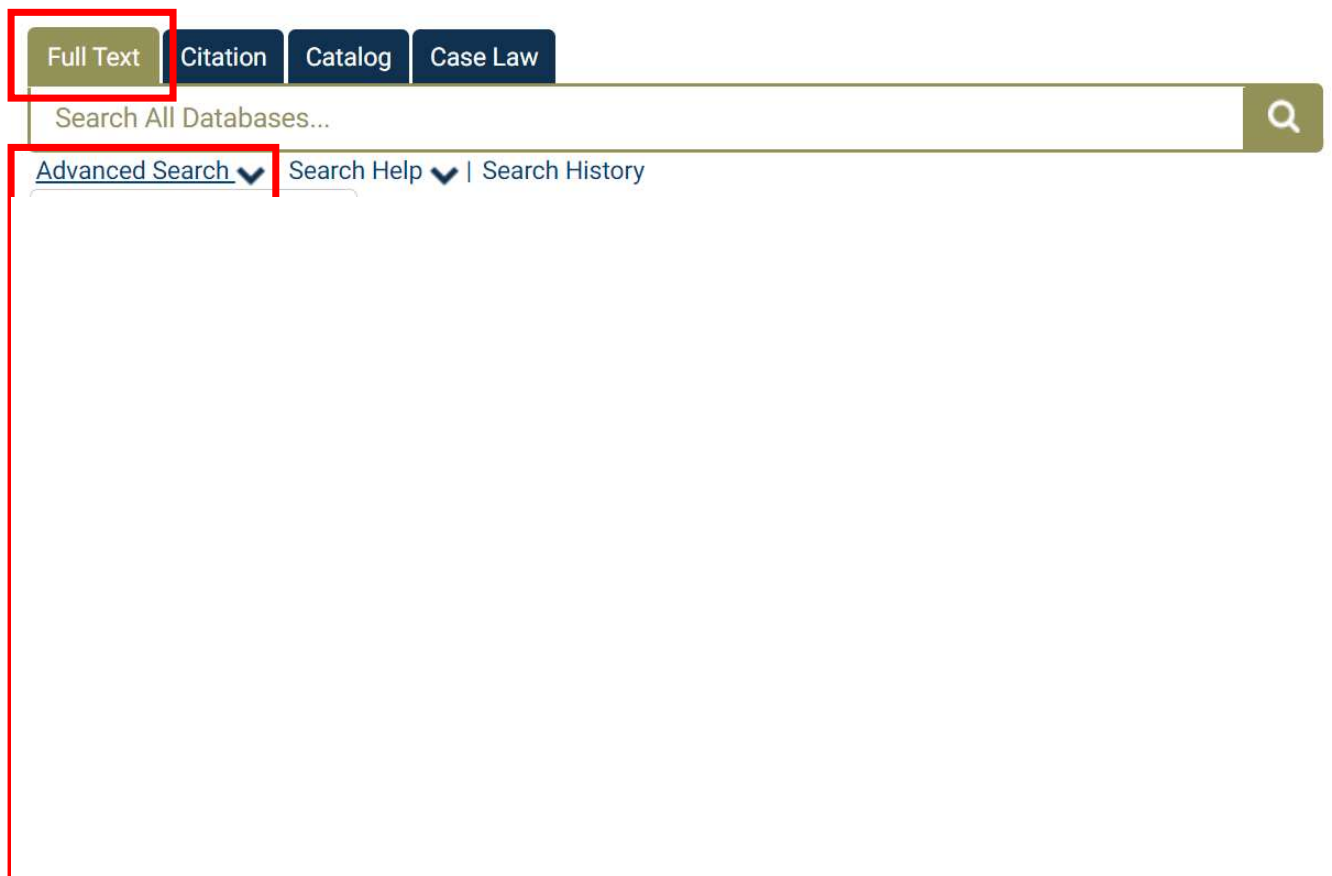

Introduction to COVID-19 in America: Response, Issues, and Law

2020 had barely begun when life as the world knew it was upended and redefined. Reports at the end of 2019 of a mysterious disease spreading rapidly through Wuhan, China made headlines in the United States, but were not met with alarm by the general American public. This new respiratory disease, in the same family as SARS and MERS, is a coronavirus, so named for the spiky halo of crowns appearing around its structure. In February 2020, the first confirmed case of this new disease, COVID-19, was confirmed in the United States in Seattle and Chicago. Symptoms in these patients were mild and distressingly common for a range of maladies that frequently occur in winter: cough, fever, shortness of breath. Restrictions on travelers from China were implemented by the federal government on February 2nd, hoping to stop the virus from entering the country. Four days later, a woman in San Jose, California, died after experiencing a flu-like disease throughout January; later testing would determine she was the first person in the United States to die of COVID-19 with no history of recent foreign travel. Her death would be later evidence of community spread—that COVID-19 was already in the United States and had been silently moving across the country unchecked since December, and with no limitation on state-to-state travel, it was still moving.

Testing was restricted at first only to individuals with known connection to or contact with foreign travel, and with all testing being funneled through the Centers for Disease Control (CDC). A faulty batch of testing kits further hampered the already slow effort. As February turned into March, more confirmed cases spread across the states. Across the sea, Italy saw its highest single-day jump in deaths from COVID-19, a tragic trend that by the end of the month would see Italy's death toll surpass China's.

March would also see the pandemic's unignorable explosion in the United States, with New York City becoming the country's epicenter. A state-wide stay-at-home order was issued by Governor Andrew Cuomo with all non-essential businesses closing, drive-thru testing sites
